

The syntax of comparative constructions

Description

The aim of this course is to provide an overview of the syntax of comparative constructions, introducing students to the most important issues concerning the topic that have been addressed in the literature from the 1970s onwards. Though all of these questions are strongly related to comparatives, we will see that providing an adequate answer to them has a bearing on other structures, too. In particular, we are going to discuss the structure of degree expressions, the phenomenon of Comparative Deletion, as well as the role of various optional ellipsis phenomena taking place in the subclause. While the main focus of this class is on English, the course takes a cross-linguistic perspective to highlight the particular properties of English. The classes will be taught in English.

Requirement: there are two options, see below.

Note that the end-term test gives less than 100% of the grade for the course: this also means that receiving a 5.0 for the test does not automatically result in failing the course. However, the end-term test **must** be taken: not taking the end-term test results in failing the course.

The final grade is given by two or three components. Depending on which option you choose, the final grade is calculated as follows:

- OPTION 1:
 - end-term test: 50%
 - mini-essay: 30%
 - reading assignment: 20%
- OPTION 2:
 - end-term test: 80%
 - reading assignment: 20%

Recommendation: Option 1

- Writing an essay is fun!
- It involves less risk than relying 80% on the result of the test.
- **You have nothing to lose:** in case you submit the mini-essay but the calculation according to Option 2 would give you a better grade than the one according to Option 1, you will automatically receive the better grade.
